**Longtime ALCC Executive Director Ann Hilton Fisher to Retire**  
*Retirement benefit in her honor planned for April 3*

Ann Hilton Fisher, the longtime Executive Director of AIDS Legal Council of Chicago, will be officially retiring on March 31. A graduate of the University of Michigan and Wayne State University Law School, Ann completed a clerkship with the Hon. Judge Fairchild of the Court of Appeals for the Seventh Circuit before joining the Legal Assistance Foundation (LAF). While at LAF, she worked first as a neighborhood attorney, then as a senior attorney with the Foundation's Disability Law Project, and later supervised the HIV/AIDS Law Project.

During her 17 years at the helm of ALCC, Ann has touched the lives of thousands of people in need and helped to transform the legal landscape for people with HIV. Ann has received numerous awards for her tireless work during her career, including honors from AIDS Foundation of Chicago, Lawyer's Trust Fund, TPAN, Chicago Bar Foundation, Public Interest Law Initiative, CALOR, and the Illinois State Bar Association, among others.
