

Letter from Executive Director Thomas Yates

Legal Council celebrated its big 30th anniversary this past year!

There is a lot to be proud of, and much has been accomplished over the past three decades. Tens of thousands of people living with illness and disability have accessed our free legal care programs, resulting in the opportunity to pursue their full human potential. But there is still so much to do.

Here is a snapshot of the over 2,400 clients whom Legal Council will serve this year:

- 95% live below the poverty line.
- 85% have no income at all.
- 50% of adult clients are survivors of childhood trauma.
- 91% have a disability.
- 60% have HIV.
- 70% of child clients are denied access to adequate education.

Legal Council's caseload continues to increase. We are expanding training and outreach, and now see people with legal problems at over a dozen service providers across the region. And as we continue to grow, Legal Council is preserving Illinois' health safety net, using class-action lawsuits and high-impact litigation to ensure that hospitals, clinics, and human service agencies caring for our clients and communities remain strong.


From our humble beginnings, Legal Council has stayed ahead of the needs of our communities and remains a client-centered, street-smart agency delivering high-quality legal services.
